Company description

Net Insight delivers products, software and services for effective, high-quality media transport, coupled with unprecedented true live OTT (over-the-top) video delivery. It is the leading provider in media transport and resource scheduling. Its vision is to enable a live and interactive media experience for anyone on earth, a global media marketplace where live content can be exchanged and interaction among TV audiences can take place in real-time

Net Insight has over 500 customers in more than 60 countries. At year-end 2016, the Company had 215 employees.

The share was listed on Nasdaq Stockholm mid cap on January 2nd 2017.

Recent developments

March 10, 2017: The Company announced that its ScheduALL Connector has won the World Teleport Association's (WTA) 2017 Award for Teleport Technology of the Year.

Net Insight's ScheduALL Connector is a revolutionary selfservice, end-to-end provisioning and scheduling solution that allows satellite and fiber network providers to easily connect with their ScheduALL broadcast customers.

February 16, 2017: The Company released Year-end 2016 report with revenues of 504m SEK, a 34% increase y-o-y with 20% organic growth.

Growth was across all regions, driven by an increased customer base and a broader product portfolio.

The growth margin was at 63% (vs 60% in 2015).


Investment conclusion
